

**Application and Database License Agreement for
The Hong Kong Polytechnic University Finger Image Database (Version 1.0)**

In order to promote research efforts in the contactless biometrics, the contactless low resolution fingerprint database is being made available to the researchers. The Hong Kong Polytechnic University (henceforth, “HKPolyU”) owns copyright of the collection of biometric images and serves as the source for the database distributed for the academic research purpose. All the requests to acquire ‘The Hong Kong Polytechnic University Finger Image Database (Version 1.0)’ must be submitted in writing by the researcher’s institution on the behalf of individual researcher or the research laboratory/centre/unit. In order to receive a copy of this database, a legal officer of the researcher’s institution must sign on this document and agree to observe the restrictions listed below. In addition to other possible remedies, failure to observe these restrictions may result in revocation of permission to use this database as well as denial of access to additional databases distributed by our university and research unit. The submission of a completed license does not automatically guarantee access to the database. The distribution of this database may be further restricted to comply with the local legal requirements.

Consent: The researcher requesting this database agrees to the following terms and conditions:

1. Redistribution: Without prior approval from The Hong Kong Polytechnic University (Principal Investigator), *The Hong Kong Polytechnic University Finger Image Database (Version 1.0)*, in whole or in part, will not be further distributed, published, copied, or disseminated in any way or form whatsoever, whether for profit or nonprofit.

2. Modification and Commercial Use: Without prior approval from HKPolyU, *The Hong Kong Polytechnic University Finger Image Database (Version 1.0)*, in whole or in part, may not be modified or used for commercial purposes. The license granted herein is specifically for the internal research purposes of Researcher, and Researcher shall not duplicate or use the disclosed database, its contents, or phrase associated with this database to any manufacture, promote, or sell products or technologies (or portions thereof) either directly or indirectly for the commercialization or any other direct for-profit purpose without the prior written permission from HKPolyU.

3. Requests for the Biometrics Database: All requests for *The Hong Kong Polytechnic University Finger Image Database (Version 1.0)* will be received and processed by the Principal Investigator.

4. Publication Requirements: Those seeking to include renderings of more than 10 images from *The Hong Kong Polytechnic University Finger Image Database (Version 1.0)* database in reports, papers, and other documents to be published or released must first obtain approval in writing from the Principal Investigator.

5. Citation: All documents and papers that report on research that uses this database should acknowledge the use of the database and include the citation for the paper ‘Ajay Kumar and Yingbo Zhou, “Human Identification using Finger Images”, *IEEE Trans. Image Processing*, April 2012’.

6. Publications to HKPolyU: A copy of all reports and papers that are for public or general release that use this database must be forwarded immediately upon release or publication to the HKPolyU Principal Investigator.
